

- VII. To prepare, edit, print, publish, issue acquire and circulate books, paper, news papers, Magazine, periodicals, gazettes, circulars and other literary, undertaking, treating, of or bearing upon any field of any education, science, Technology, social work and development of Trust.
- VIII. To provide, organize, Maintain, control, develop and conduct the education, vocational, industrial and otherwise for the mentally affected sections of society and Drug addicted persons.
- IX. To start, hold, run managed and organize educational guidance centre, career guidance centre for enrolment in the various school/collage/institutions and achieving the jobs of the different service line centre govt. Bank, State gov. and other private & Public sector for all general or financially and socially weaker section of society SC, ST & OBC CASTE OF students.
- X. To participate in and co-operative with as far as possible, such recognized institutions as exist or may be founded in the further for cognate objects in India and abroad.
- XI. To open, found, establish, establish, set-up, run maintain, assists, finance, support and/or help in the setting up and/or maintaining and/or running Hospitals, Boarding House, libraries, Reading-Rooms, gymnasium, kala-kendras, Welfare centre and other training and vocational institutes in India and abroad.

To do all such things as are incidental, necessary of conductive to attainment of all or any of the objects of the trust.

- XVI. To run awareness programme in the rural and urban area and advice people to form self help group, women empowerment, legal rights to women, consumer right, dalit & human right, etc. to all kinds of people.
- XVII. To raise fund, loan and donation from individual, private agency, government agency, Bank, Corporation, National and international agency for realizing the objectives of Trust.

6. If any one or more of the objects specified in clause (4) of these presents are held not be objects the Trust, the Board of trustees shall amend by resolution and the same shall be incorporated in these present. 7. Beneficiaries – The beneficiaries of this trust are the public at large of outside inside of India.

8. Trust Fund:- The founder Trustee hereby declares that a sum of Rs.21001/- (Rupees Twenty One thousand and one only ) handed over in trust and dedicated for public, Society and Education purposes shall by the trustee upon trust and also any other money or properties which the trust may acquire from time to time for augmenting the trust fund. The financial year of the trust shall be 1<sup>st</sup> April to 31<sup>st</sup> March.

9. Founder Trustee: the founder Trustee shall be SMT. GEETA SHARMA D/O-BHAGIRATH ROY residing at DOMATAND P.O. JAMGORIA DIST. Bokaro (JHARKHAND)

The founder Trustee shall hold office for life. She is entitled to Nominate her successors who also hold office for life with similar power of further to Nomination. The Founder Trustee shall have power to nominate minimum nos. of three special Trustee. They have hold office for life. Founder trustee shall have power to nominate one or more ordinary Trustee from time to time for such period or periods as the nomination may provide and the Founder Trustee will also have power to remove such special or ordinary Trustee and Trustees so nominated by her before expiry of the period for which they are nominated.

- II. The Trust shall have a Board of Governor's to assist the Founder Trustee in carrying out the aim and objective of the pleasure of the Founder Trustee, at least two special Trustees are the member of Board of Governors'.
- III. There shall be a Board of Advisors, formed and nominated by Board of Governor.
- IV. Founder Trustee of his nominee shall be the president Board of Governors and Board of Advisor.
- V. The Founder Trustee shall have power to reconstitute the Board of Government and advisor at any time and to remove any individual member.
- VI. The Board of Governor appoints General Secretary among the Board of Governor to assist the Founder Trust in carrying out the objective of the Trust.
- VII. The Executive Committee shall be constituted by the Founder Trustee in consultation with the Board of Governor with a maximum no. of five members. Two are President & general Secretary of Board of Governor is the member of Executives' committee. The Executives committees have the power to deal day to day activities of the Trust.
- VIII. The quorum of the Board of Governor and Advisor are one-third of the member.

- 11. The Trustee shall open the Bank accounts in any Nationalized Bank /private Bank/post office where shall deposited all money and contributions received by the Trust and maintain the Bank accounts. The Trust shall cause to maintained proper books of accounts required by law. The books of accounts shall be subjects to audit periodically by qualified chartered Accounts.
- 12. The Fonder Trustee in consultations with a Board of governors shall have the power to form rules and regulations governing the trust consistent with the objects of the Trust.
- 13. The founder Trustee shall be the person to act for and behalf of the Trust and to open operate Independently or jointly with other trustee the bank accounts in any Nationalized Bank private Bank, post office of India and out side India and to receive and pay money on behalf of the Trust.
- 14. The Founder Trustee shall have power to collect donation, grant and borrow funds for implementing and carrying out the objective and purpose of the trust from person, Financial institution and Nationalized Bank private Bank post office on the security or without security on such interest prevalling in the institutions and to execute necessary security document on behalf of the Trust.
- 15. The General secretary of Governing Body of the trust with consent of the Founder trustee shall have power to appoint or engage and at their discretion, remove, dismiss or suspend any of the staff/employee in permanents or temporary or special service in connection with the work of the trust as they may from time think fit to determine their power and duties and fix their salaries or emoluments and to require security in such instance and at such amount as the trustee may think fit.

16. For the purpose of carrying out the objective of the Trust, it shall be lawful for the Founder Trustee to acquire by purchase or in lease or otherwise any immovable property of tenure and case of vacant land. 17. Alteration of benefits conferred by the Trust. In the event to charge circumstances making it impossible to continue any of the schemes of the trust. The Founder Trustee shall apply the Trust funds and the property to any other subjects of the like nature or to any other institutions or to trust having similar objectives.
18. The founder trustee shall have power from time to time to alter the deed of trust or any of its clauses as the founder trustee or Board of Governor with consent of Founder trustee may think fit.
19. The Trust hereby declares is irrevocable.
